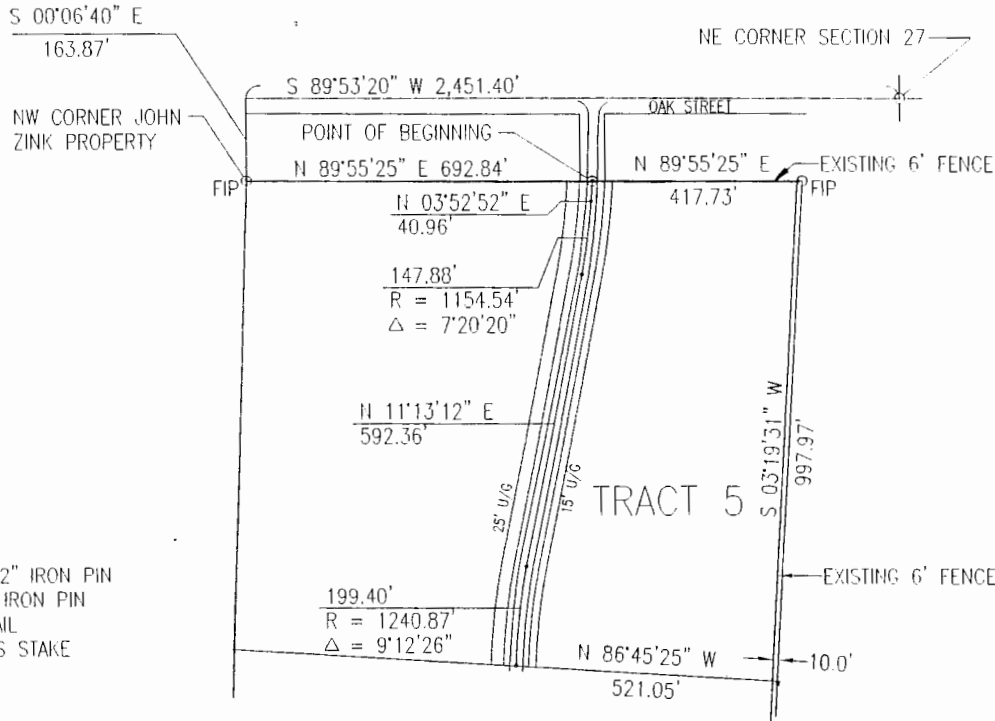
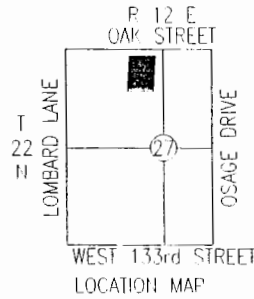


PLAT OF SURVEY

TRACT 5 JOHN ZINK PROPERTY



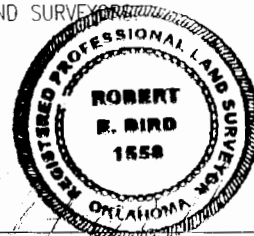
DESCRIPTION

A PARCEL OF LAND IN THE EAST HALF (E/2) OF THE NORTHWEST QUARTER (NW/4) OF SECTION TWENTY-SEVEN (27), TOWNSHIP TWENTY-TWO (22) NORTH, RANGE TWELVE (12) EAST OF THE INDIAN BASE AND MERIDIAN, OSAGE COUNTY, STATE OF OKLAHOMA, ACCORDING TO THE U.S. GOVERNMENT SURVEY THEREOF, MORE PARTICULARLY DESCRIBED AS:

COMMENCING AT THE NORTHEAST CORNER OF SECTION 27, TOWNSHIP 22 NORTH, RANGE 12 EAST THENCE S89°53'20"W A DISTANCE OF 2,451.40 FEET; THENCE S0°06'40"E A DISTANCE OF 163.87 FEET; THENCE N89°55'25"E A DISTANCE OF 692.84 FEET TO THE POINT OF BEGINNING; THENCE N89°55'25"E A DISTANCE OF 417.73 FEET; THENCE S03°19'31"W A DISTANCE OF 997.97 FEET; THENCE N86°45'25"W A DISTANCE OF 521.05 FEET; THENCE A DISTANCE OF 199.40 FEET ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 1240.87 FEET AND A DELTA OF 9°12'26"; THENCE N11°13'12"E A DISTANCE OF 592.36 FEET; THENCE A DISTANCE OF 147.88 FEET ALONG A CURVE TO THE LEFT HAVING A RADIUS OF 1154.54 FEET AND A DELTA OF 7°20'20"; THENCE N03°52'52"E A DISTANCE OF 40.96 FEET TO THE POINT OF BEGINNING. SAID TRACT OF LAND CONTAINING 462,288 SF OR 10.61 ACRES MORE OR LESS.
